"This issue of digital MNCs collecting massive advertising revenue from other countries and paying minimal tax at a tax haven has to be sorted out at the G20 or some such fora soon," said Jayant Dasgupta, former Indian Ambassador to the WTO.

There is also the related question of the flow of big data across national boundaries and its commercial exploitation.

"The ownership of such data is a question which will have to be resolved plurilaterally, if not at the WTO," Dasgupta said.

The USTR had initiated Section 301 investigation against France in July 2019 after the country imposed a 3 per cent tax on gross revenues generated from providing digital interface services and targeted advertising services.
